CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PATRICK J JOHNSTON RT 1 BOX 317 WOODBURN OR 97071

confirms the right to use the waters of CHAMPOEG CREEK AND RESERVOIR CONSTRUCTED UNDER PERMIT R-5064, A TRIBUTARY OF WILLAMETTE RIVER for IRRIGATION of 32.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 78.0 ACRES.

This right was perfected under Permit 32873. The date of priority is FEBRUARY 26, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.02 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the period of March 1 through April 30 of each year from direct flow and storage from reservoir constructed under Permit R-5064, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be subject to the terms and agreement between Arthur McKay, Patrick Johnston, Walter Wilmes and Neal Miller, recorded at page 979, Volume 4, Miscellaneous Records of the State Engineer and by reference made a part hereof, and shall conform to such reasonable rotation system as may be ordered by the proper state officer..

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance-of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
