confirms the right to use the waters of SIMPSON CREEK, tributary to COQUILLE RIVER for IRRIGATION OF 9.8 ACRES OF CRANBERRIES.

This right was perfected under Permit 25032. The date of priority is JULY 8, 1957. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.98 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-TENTH of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 0.75 acre foot for each acre irrigated in any 30 day period and shall be still further limited to a diversion of not to exceed 6 acre feet per acre during the irrigation season of each year; if for irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
