CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAUL R. & ROSETTA A KENT 55965 PORTLAND RD BANDON OR 97411

confirms the right to use the waters of THREE RESERVOIRS, CONSTRUCTED UNDER PERMIT R-5489, tributaries to SIMPSON CREEK for SUPPLEMENTAL IRRIGATION AND HARVESTING OF CRANBERRIES OF 9.8 ACRES.

This right was perfected under Permit 34497. The date of priority is NOVEMBER 28, 1969. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 5.4 ACRE FEET STORED WATER ONLY, BEING 2.7 ACRE FEET FOR IRRIGATION AND 2.7 ACRE FEET FOR HARVESTING CRANBERRIES, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
