A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a fish screen or by-pass device at the new point of diversion.

This certificate is issued to correct an error in the number of acres and confirms an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered May 9, 2005, and together with certificate 81415 supersedes Certificate 16406 and Certificate 86488, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
