confirms the right to use the waters of WAGNER CREEK, a tributary to BEAR CREEK for IRRIGATION of 368.2 ACRES, SUPPLEMENTAL IRRIGATION OF 2.1 ACRES, AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1854.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.13 CUBIC FEET PER SECOND.
