## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GREEN VILLA FARMS PO BOX 37 INDEPENDENCE OR 97351

confirms the right to use the waters of WILLAMETTE RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 140.5 ACRES.

This right was perfected under Permit 15237. The date of priority is APRIL 6, 1942. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.76 CUBIC FEET PER SECOND, if available at the authorized points of diversion, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINTS OF DIVERSION approved by an order of the Water Resources Director entered MAY 4, 1992, at Special Order Volume 46, Page 245, approving Transfer Application 6456, and together with Certificate 67321, supersedes Certificate 50398, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
