CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WILLAMINA CREEK, tributary to YAMHILL RIVER for DOMESTIC USE.

This right was perfected under Permit 14420. The date of priority is JUNE 10, 1940. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.45 CUBIC FOOT PER SECOND, if available at the authorized point of diversion, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:
