CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MOUNTAIN LAKE BIBLE CAMP 4849 S 6TH KLAMATH FALLS OR 97603

confirms the right to use the waters of VARNEY CREEK, tributary to KLAMATH LAKE for FIRE PROTECTION AND IRRIGATION OF 0.95 ACRE.

This right was perfected under Permit 27174. The date of priority is FEBRUARY 7, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.07 CUBIC FOOT PER SECOND (CFS), or its equivalent in case of rotation, measured at the point of diversion. When used for irrigation the amount of water diverted shall not exceed 11 gallons per minute (0.024 CFS). The total quantity of water diverted for irrigation shall not exceed 2.85 acre feet during the irrigation season of each year.

The use of water for irrigation is limited to the irrigation season, March 1 to October 31 of each year.

The point of diversion is located as follows:

The amount of water used for irrigation under this right is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
