CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the PUDDING RIVER, UNNAMED STREAM, AND RESERVOIR constructed under Application R-44205, Permit R-5107, tributary to the MOLALLA RIVER for IRRIGATION of 28.0 ACRES and SUPPLEMENTAL IRRIGATION of 18.8 acres.

This right was perfected under Permit S-33026. The date of priority is OCTOBER 27, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.59 CUBIC FOOT PER SECOND (CFS), being 0.35 cfs from Pudding River for primary irrigation and 0.24 cfs from the unnamed stream and reservoir for supplemental irrigation, or its equivalent in case of rotation, measured at the points of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from the reservoir constructed under Permit R-5107. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
