CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, within the TUALATIN RIVER BASIN for SUPPLEMENTAL IRRIGATION of 8.3 ACRES.

This right was perfected under Permit G-10621. The date of priority is MAY 12, 1986. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 7.6 gallons per minute, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered March 24, 1999, at Special Order Volume 53, Page 478, approving Transfer Application 7207, and together with Certificate 76062, supersedes Certificate 68502, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
