CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NEAL AND ANNA DOW
28000 SE PAULINA HWY
PRINEVILLE OR 97754

confirms the right to use the waters of HORSE HEAVEN CREEK AND RESERVOIR, CONSTRUCTED UNDER PERMIT R-1130, tributaries to CROOKED RIVER for IRRIGATION of 31.3 ACRES FROM NATURAL FLOW FROM HORSE HEAVEN CREEK AND STORAGE, AND SUPPLEMENTAL IRRIGATION of 106.2 ACRES FROM STORAGE ONLY.

This right was perfected under Permit S-20200. The date of priority is MARCH 2, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.44 CUBIC FEET PER SECOND, AND SHALL BE FURTHER LIMITED TO A DIVERSION OF 0.78 CUBIC FEET PER SECOND FROM DIRECT FLOW OF HORSE HEAVEN CREEK, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1130.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


When required by the Department, the water user shall install and maintain a headgate, in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate describes that portion of the water right confirmed by Certificate 86198, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JAN 11 2011, approving Transfer Application T-11123.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
