CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NEAL AND ANNA DOW 28000 SE PAULINA HWY PRINEVILLE OR 97754

confirms the right to use the waters of BONNIEVIEW RANCH RESERVOIR CONSTRUCTED UNDER PERMIT R-6551, tributary to CROOKED RIVER for SUPPLEMENTAL IRRIGATION of 174.8 ACRES.

This right was perfected under Permit S-41174. The date of priority is DECEMBER 8, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 242.6 ACRE FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
