CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JESPERSON-EDGEWOOD, Inc
12941 SWAN LAKE ROAD
KLAMATH FALLS OR 97603

confirms the right to use the waters of HAMAKER WELL, tributary to ANDERSON CREEK (SWAN LAKE) for IRRIGATION of 112.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 36.0 ACRES.

This right was perfected under permit U-343. The date of priority is JULY 19, 1949. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.86 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW


