The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.634 CUBIC FOOT PER SECOND, subject to the provisions of paragraph 33 of said decree.

- 1. Prior to October 1, 2008, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- Prior to October 1, 2008, the water user shall install and maintain a fish screen or fish by-pass device. The
 type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and
 Wildlife prior to beginning of construction shall be installed under the supervision of the Department of Fish
 and Wildlife.
