## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

COLUMBIA EMPIRE FARMS, INC. (R-2 RANCH) 31461 NE BELL ROAD SHERWOOD, OR 97140

confirms the right to use the waters of TROUT CREEK, tributary to DESCHUTES RIVER for IRRIGATION of 28.35 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JEFFERSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 57. The dates of priority are 1885 and 1886.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.5 ACRE FEET PER ACRE DURING ANY PERIOD OF 30 DAYS OR 6 ACRE FEET PER ACRE DURING ANY IRRIGATION SEASON, (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION AT THE HEALY AND COMPANY DITCHES) or its equivalent in case of rotation, measured at the points of diversion.

The quantity of water diverted at the new points of diversion for the **1886 rights**, shall not exceed the quantity of water available from the original point of diversion; being the Johnson Gallery.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE, POINT OF DIVERSION, AND ADD ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered July 12, 2004, at Special Order Volume 60, Page 481, approving Transfer Application T-9188, and together with Certificate 80673, supersedes Certificate 79646, State record of Water Right Certificates.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
