confirms the right to use the waters of TWO WELLS, within the PUDDING RIVER BASIN for SUPPLEMENTAL IRRIGATION of 3.6 ACRES.

This right was perfected under Permit G-5359. The date of priority is March 2, 1971. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.04 cubic foot per second, if available at the original well; NE¼ NE¼, AS PROJECTED WITHIN DLC 55, SECTION 19, T 6 S, R 1 W, W.M.; 890 FEET SOUTH AND 280 FEET EAST FROM THE NW CORNER, NEWSON DLC 55, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department..

The quantity of water diverted at the additional points of appropriation, together with that diverted from the original point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered November 10, 1998, at Special Order Volume 52, Page 976, approving Transfer Application 7904, and together with Certificate 75872, supercedes Certificate 45549, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
