CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WOLF CREEK, a tributary to POWDER RIVER for IRRIGATION of 118.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is 1876 for 80.0 acres, 1893 for 19.0 acres and 1895 for 19.0 acres.

The amount of water used for irrigation is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be subject to all other conditions and limitations contained in the decree.

The point of diversion is located as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

device must meet ODFW's design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screening and/or by-pass device meets ODFW's criteria. Once installed the water user shall maintain and operate the fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.

When required by the Department, the water user shall install, maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION and reflects the CANCELLATION of water rights approved by an order of the Water Resources Director entered May 18, 2009, and recorded at Special Order Volume 77, pages 788 to 796, approving Transfer Application T-7503. This certificate supersedes Certificate 8587, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
