CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN ZERBA
83772 PRUNEDALE ROAD
MILTON-FREEWATER, OR 97862

confirms the right to use the waters of the Walla Walla River, a tributary of the Columbia River, for the purpose of IRRIGATION of 8.23 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12, Page 9. The dates of priority are 1875, 1881, 1894 and 1896.

The use is limited to 1.0 miner's inch per acre, or 0.006 cubic foot per second, for the 1875 priority date and 1.5 miner's inches per acre, or 0.30 cubic foot per second for all other priority dates, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and the right shall be subject to all other conditions and limitations contained in the above-described decree.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate confirms an order of the Water Resources Director entered on 8/14/12, and recorded in Special Order Volume 06, Page 51 approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificates 12604 and 13080.
