confirms the right to use the waters of the Walla Walla River, a tributary of the Columbia River, for the purposes of STOCK and IRRIGATION of 7.0 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12, Page 9. The date of priority is 1885.

The use is limited to 1.5 miner's inches per acre, or 0.26 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the source.
