## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the Walla Walla River, a tributary of the Columbia River, for IRRIGATION of 22.30 ACRES.

This right was perfected under Permit S-1216. The date of priority is MARCH 25, 1912. The amount of water to which this right is entitled is limited to an amount beneficially used and shall not exceed 0.28 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE- EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall confirm to such reasonable rotation system as may be ordered by the proper state officer.
