CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PLEASANT VIEW IRRIGATION COMPANY
 WALLA WALLA RIVER IRRIGATION DISTRICT
 605 LAMB STREET
 MILTON-FREEWATER, OR 97862

confirms the right to use the waters of the Little Walla Walla River, a tributary of the Walla Walla River, for IRRIGATION of 496.67 ACRES.

This right was perfected under Permit S-1216. The date of priority is MARCH 25, 1912. The amount of water to which this right is entitled is limited to an amount beneficially used and shall not exceed 6.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE- EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
