 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PLEASANT VIEW IRRIGATION CO., INC.  
 WALLA WALLA RIVER IRRIGATION DISTRICT  
 605 LAMB STREET  
 MILTON-FREEWATER, OR 97862

confirms the right to use the waters of the WALLA WALLA RIVER, a tributary of the COLUMBIA RIVER, for the purpose of SUPPLEMENTAL IRRIGATION of 41.40 ACRES.

The right was perfected under Permit S-26001. The date of priority is JANUARY 16, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.04 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 0.0375 of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
