## **CERTIFICATE OF WATER RIGHT**

THIS CERTIFICATE ISSUED TO:

CHARLES TOMPKINS FORT ROCK, OREGON 97735

confirms the right to use the waters of WELL 2 in the FORT ROCK BASIN for IRRIGATION OF 136.75 ACRES.

This right was perfected under Permit G-7484. The date of priority is MAY 6, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.71 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in the location of the point of appropriation described on Certificate 86684. This Certificate supersedes Certificate 86684 and describes the portion of water right Certificate 52623, NOT modified by the provisions of an order of the Water Resources Director entered November 5, 2010, and recorded at Volume 83, Pages 20-24, approving Transfer Application T-10949.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
