- 3. The dam is to be operated and maintained in accordance to the approved plans and specifications.

This certificate describes that portion of the water right confirmed by Certificate 83204, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered _______ APR_0_5_2011_____, approving Transfer Application T-10977 and also corrects a scrivener's error in Certificate 83204 which incorrectly identified the stream to which Ash Swale is tributary.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within 60 days of the date of service.
