CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TWIN CREEK FARMS 29385 S. NEEDY RD CANBY, OR 97013

confirms the right to use the waters of TWO WELLS in the BEAR CREEK BASIN for IRRIGATION of 23.8 ACRES FROM WELL 1 AND IRRIGATION OF 76.2 ACRES FROM WELL 2.

This right was perfected under Permit G-4921. The date of priority is SEPTEMBER 23, 1971. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.25 CUBIC FEET PER SECOND, BEING 0.3 CUBIC FOOT PER SECOND FROM WELL 1 AND 0.95 CUBIC FOOT PER SECOND FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply and any right existing for the same land shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
