CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EAGLE POINT IRRIGATION DISTRICT
PO BOX 157
EAGLE POINT, OR 97524

confirms the right to use the waters of LITTLE BUTTE CREEK and WASTE WATER, tributaries to the ROGUE RIVER for SUPPLEMENTAL IRRIGATION of 43.63 ACRES.

This right was perfected under Permit S-18201. The date of priority is MARCH 2, 1948. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.546 CUBIC FOOT PER SECOND, being 0.404 cfs from Little Butte Creek and 0.142 from Waste Water, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year; provide further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and shall also be limited to the water available at the proposed point of diversion of waste water, and shall not carry with it the right to compel the continuance of the waste water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 19643, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered APR 07 2011, approving Transfer Application T-11179.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
