CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JEDEDIAH W. AYLETT
75816 FRONTAGE LANE
HERMISTON OR 97838

confirms the right to use the waters of a well, in the UMATILLA RIVER for MINING WATER USE.

This right was perfected under Permit U-725. The date of priority is MAY 2, 1955. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.064 cubic foot per second and is further limited to 15.36 ACRE-FEET EACH IRRIGATION SEASON, if available at the original well, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The period of allowed use of water is limited to the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation described as follows:

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

In the future the water user may be required to install and maintain adequate treatment facilities, meeting current Department of Environmental Quality requirements, before discharging the water after use.


Water shall be acquired from the same aquifer as the original point of appropriation.

This right is subject to the terms and conditions of the Findings, Conclusions and Order, on the Question of Determination of a Critical Ground Water Area in the Ordnance Area, Morrow and Umatilla Counties, Oregon, of the Water Resources Director, entered April 2, 1976, at Special Order Volume 27, Page 40.

This certificate is issued to confirm a change in USE, PLACE OF USE, and POINT OF APPROPRIATION approved by an order of the Water Resources Director entered December 14, 1994, at Special Order Volume 48, Page 367, approving Transfer Application 7105, and together with Certificate 68429, supersedes Certificate 60557, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
