## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BEAR CREEK, tributary to ROGUE RIVER for INDUSTRIAL USE.

This right was perfected under Permit 19282. The date of priority is FEBRUARY 27, 1950. The amount of water to which this right is entitled is limited to an amount actually used beneficially. The use may be exercised year round at the maximum flow rate of 0.443 CFS, not to exceed 320.3 acre-feet total annual volume of water for industrial use, or its equivalent in case of rotation, measured at the point of diversion.
