CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THREE MILE CANYON FARMS LLC
75906 THREEMILE RD
BOARDMAN OR 97818

confirms the right to use the waters of A WELL, tributary to MCALISTER SLOUGH for IRRIGATION of 609.2 ACRES.

This right was perfected under Permit G-3362. The date of priority is JULY 7, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.81 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director entered August 9, 2004, at Special Order Volume 61, Page 64, approving Transfer Application 9212, and supersedes Certificate 41380, State record of Water Right Certificates.

The transfer final order had a condition that indicated that the portion of Certificate 41380 not modified by the order be incorporated into the confirming certificate. The following place of use table describes that portion.



The issuance of this superseding certificate for the portion not modified does not confirm the status of the water right in regard to the provisions of an order of the Water Resources Director entered August 9, 2004.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
