CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALA VISTA ORCHARDS
MEDFORD, OR 97501

confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary to the ROGUE RIVER for IRRIGATION and SUPPLEMENTAL IRRIGATION of 105.4 ACRES.

This right was perfected under Permit S-15987. The date of priority is SEPTEMBER 19, 1944. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.32 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of April 2 to October 31 of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Portion of this right are supplemental to the right perfected under Permit S-6396. At the time this right was perfected, Permit S-6396 was not fully developed. Permit S-6396 was not perfected for all lands described by Certificate 15781 as


supplemental. This right was perfected for irrigation on those lands for with Permit S-6396 was not perfected and for supplemental irrigation on those lands for which Permit S-6396 was perfected.

This certificate corrects errors described on Certificate 87004. This Certificate supersedes Certificate 87004 and describes that portion of the water right confirmed by Certificate 84273, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered April 7, 2011, and recorded at Volume 83, Pages 976 through 972, approving Transfer Application T-11179. .

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
