CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of EVANS CREEK, tributary to ROGUE RIVER for IRRIGATION of 5.0 ACRES.

This right was perfected under Permit 7911. The date of priority is APRIL 30, 1927. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, if available at the original point of diversion, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available at the original point of diversion described as follows:

The water user shall maintain and operate a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
