confirms the right to use the waters of EVANS CREEK, tributary to ROGUE RIVER for IRRIGATION of 31.0 ACRES, DOMESTIC, AND STOCK USE .

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1896. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.52 CUBIC FOOT PER SECOND, if available at the original point of diversion, or its equivalent in case of rotation, measured at the point of diversion.
