## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STANFIELD HUTTERIAN FARM c/o JOHN STAHL 36345 DESPAIN GULCH ROAD STANFIELD, OR 97875

confirms the right to use the waters of COLUMBIA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION of 3052.3 ACRES.

This right was perfected under Permit S-37833. The date of priority is FEBRUARY 26, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 40.63 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
