CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN TROY PLEASANT VALLEY OR 97814

confirms the right to use the waters of STRAW RANCH CREEK FOR TRACT #1, ALDER CREEK FOR TRACTS #2 AND #3, tributaries to the BURNT RIVER for IRRIGATION of 27.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 134. The date of priority is 1862 for 7.5 ACRES (TRACT #1), 1864 for 5.0 ACRES (TRACT #2) AND 1880 FOR 15.0 ACRES (TRACT #3).

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.0 ACRE FEET PER ACRE during any irrigation season (with the further limitations contained in Paragraph 64 of said decree).

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
