CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EVERETT J. and DOROTHY L. BECRAFT

LAKEVIEW, OREGON 97630

confirms the right to use the waters of A WELL in the MILL CREEK basin, for IRRIGATION of 295.44 ACRES.

This right was perfected under Permit G-3529. The date of priority is JULY 12, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.09 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of appropriation from the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH (1/80) of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
