confirms the right to use the waters of WELL 9 in the Columbia River Basin for MUNICIPAL USE.

This right was perfected under Permit G-443. The date of priority is DECEMBER 19, 1956, for 0.11 CUBIC FEET PER SECOND (CFS) and FEBRUARY 7, 1957 for 0.89 CFS. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.0 CFS or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The quantity of water diverted at Well 9 shall not exceed what was lawfully available at the original point of appropriation at Well 3 described as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.


Water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated.

This certificate is issued to confirm a change in place of use and an additional point of appropriation approved by an order of the Water Resources Director entered March 28, 2005, at Special Order Volume 63, Page 497, approving Transfer Application 9809, supersedes Certificate 74802 State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
