CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. J. MURPHY ASHLAND OR 97520

confirms the right to use the waters of WALKER CREEK, a tributary to BEAR CREEK for IRRIGATION of 10.0 ACRES AND DOMESTIC USE IN TRACT NO. 1; AND IRRIGATION of 42.62 ACRES, SUPPLEMENTAL IRRIGATION OF .38 ACRES, DOMESTIC AND STOCK USE FOR TRACT NO. 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1878 for Tract No. 1, and 1860 for Tract No. 2.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.2 CUBIC FOOT PER SECOND for Tract No. 1; and 0.54 CUBIC FOOT PER SECOND for Tract No. 2, or its equivalent in case of rotation, measured at the point of diversion.

A description of the place of use to which this right is appurtenant is as follows:

This Certificate supersedes Certificate 86614, and describes the portion of water right Certificate 15922 NOT modified by the provisions of an order of the Water Resources Director entered September 29, 2010, and recorded at Volume 81, Pages 999-1006, approving Transfer Application T-9616 and partial diminishment of a portion of Certificate 15922.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within 60 days of the date of service.
