CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMAN R FOLEY 1129 SLEEPY HOLLOW LOOP GRANTS PASS OR 97527

confirms the right to use the waters of APPLEGATE RIVER AND APPLEGATE RESERVOIR, CONSTRUCTED UNDER PERMIT R-7810, TRIBUTARIES OF THE ROGUE RIVER, for IRRIGATION of 1.66 ACRES AND SUPPLEMENTAL IRRIGATION of 5.66 ACRES.

This right was perfected under Permit S-46138. The date of priority is AUGUST 3, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.02 CUBIC FOOT PER SECOND AND 10.0 ACRE FEET or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, from direct flow, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract 1-07-10-W0329 between the Bureau of Reclamation and the water user, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
