CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH E. AND MARY M. CUNNINGHAM

confirms the right to use the waters of WELL 6, tributary to the NORTH SANTIAM RIVER for IRRIGATION of 47.0 ACRES and SUPPLEMENTAL IRRIGATION of 4.3 ACRES.

This right was perfected under Permit G-10727. The date of priority is MAY 12, 1987. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.64 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use of water shall be limited when it interferes with the prior surface water rights of others.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed change in point of diversion approved by an order of the Water Resources Director entered JUL 20 2011, at Special Order Volume 80, Page 989 which approved Transfer Application T-10411 and also a diminution of 4.3 acres from primary to supplemental irrigation. This certificate supersedes Certificate 65496, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
