CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELDA CRANE, WAYNE A. AND LINDA C. HEALY

JACKSONVILLE, OR 97530

confirms the right to use the waters of A SUMP WELL in the APPEL GATE RIVER BASIN for the purpose of THE SUPPLEMENTAL IRRIGATION of 79.7 ACRES.

This right has been perfected under Permit G-8003. The date of priority is FEBRUARY 7, 1978. This right is limited to not more than 0.99 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by Certificate 60701, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUG 15 2011, approving Transfer Application T-10159.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
