CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELDA CRANE, WAYNE A. AND LINDA C. HEALY
900 HAMILTON RD
JACKSONVILLE, OR 97530

confirms the right to use the waters of APPELEGATE LAKE RESERVOIR, a tributary of APPELEGATE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION of 79.7 ACRES.

This right was perfected under Permit 46141. The date of priority is August 12, 1981. This right is limited to not more than 50.0 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of and not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract No. 2-07-10-W0422, or a satisfactory replacement, between the bureau of Reclamation and the applicant, a copy of which is one file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to correctly identify the certificate number as certificate 87147 and supersedes certificate 81747 issued on August 15, 2011, and no other certificate.

This certificate describes that portion of the water right confirmed by Certificate 60702, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 15, 2011, approving Transfer Application T-10159.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
