CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALAN S. and JUDY L. JACOBS
28976 N. RIVER ROAD
PRAIRIE CITY, OREGON 97869

confirms the right to use the waters of ROBERTS CREEK, a tributary of JOHN DAY RIVER, for IRRIGATION of 96.7 ACRES and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1885. The period of use of water under this right is limited to the time period of APRIL 1 through JUNE 30 of each year.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH (1/40) of one cubic foot per second per acre irrigated to June 1 and ONE-EIGHTIETH (1/80) cubic foot per second per acre thereafter; further limited to 1.0 acre-foot per acre per calendar month to June 1 and no more than a total of 2.75 acre-feet per acre during the irrigation season April 1 through June 30, measured at the point of diversion from the source.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


This certificate confirms the right modified by an order of the Water Resources Director, entered AUG 01 2011, and recorded in Special Order Volume 84, Page 888 to Page 891, diminishing and limiting the irrigation season to the time period of April 1 through June 30 of each year.

This certificate, together with Certificate 87151 supersedes Certificate 25835.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
