## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. J. STANBRO PO BOX 97 PRAIRIE CITY, OREGON 97869

confirms the right to use the waters of ROBERTS CREEK, a tributary of JOHN DAY RIVER, for IRRIGATION of 123.8 ACRES and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1885.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH (1/40) of one cubic foot per second per acre irrigated to June 1 and ONE-EIGHTIETH (1/80) cubic foot per second per acre thereafter; further limited to 1.0 acre-foot per acre per calendar month to June 1 and 4.0 acre-feet per acre during season April 1 to September 30, measured at point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate, together with Certificate 87150 supersedes Certificate 25835.
The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
