confirms the right to use the waters of ROBERTS CREEK, a tributary of JOHN DAY RIVER, for IRRIGATION of 64.2 ACRES.

This right was perfected under Permit 48144. The date of priority is SEPTEMBER 30, 1983. This right is limited to 1.6 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The period of use of water under this right is limited to the time period of APRIL 1 through JUNE 30 of each year.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH (1/40) of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

This certificate confirms the right modified by an order of the Water Resources Director, entered AUG 0 1 2011 , and recorded in Special Order Volume 84, Page 888 to Page 891,
diminishing and limiting the irrigation season to the time period of April 1 through June 30 of each year.
This certificate supersedes Certificate 82319.
The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows
