confirms the right to use the waters of A WELL, tributary to the WILLAMETTE RIVER for AIR CONDITIONING.

This right was perfected under Permit G-3965. The date of priority is JANUARY 23, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.80 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of appropriation is located as follows:

This right is subject to the provision that use of water for air conditioning in excess of 5,000 gallons per day shall be subsequent in priority to future beneficial consumptive use unless a two well system is constructed and all water wasted from the system is recharged to the same ground water reservoir from which it was withdrawn and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed change in point of diversion approved by an order of the Water Resources Director entered <u>June 23, 2010</u>, at Special Order Volume 81, Page 255, approving Transfer Application T-11014 and supersedes Certificate 44645, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
