CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JULIA RITTER
28100 RITTER RD
BONANZA, OR 97623

confirms the right to use the waters of WELLS 1 AND 2 in the WILDHORSE CREEK BASIN for IRRIGATION of 86.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 205.9 ACRES.

This right was perfected under Permit G-3653. The date of priority is JULY 29, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.26 CUBIC FEET PER SECOND (CFS), BEING 1.08 CFS FROM WELL 1 AND 2.18 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct scrivener's errors in the location of Well 2 and in the rate in cfs described on Certificate 79446. This Certificate supersedes Certificate 79446, and describes the portion of water right Certificate 77753, NOT modified by the provisions of an order of the Water Resources Director entered April 9, 2002, and recorded at Volume 56, Page 238, approving Transfer Application T-8705.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
