confirms the right to use the waters of the ROGUE RIVER, tributary to the South Yamhill River, and the SOUTH YAMHILL RIVER, tributary to the Yamhill River, for QUASI-MUNICIPAL USES.

This right was perfected under Permit S-15049. The date of priority is AUGUST 9, 1941. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.40 CUBIC FOOT PER SECOND and further limited to a maximum total quantity of 168.8 acre-feet (55 million gallons) per year, as measure at the point of diversion.

The water user shall maintain a fish screen or fish by-pass device as appropriate, at the new point of diversion.

This certificate is issued to confirm a change in place of use, character of use, and an additional point of diversion approved by an order of the Water Resources Director entered July 20, 2007, at Special Order Volume 72, Page 683, approving Transfer Application 10028, supersedes Certificate 14538, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
