CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HENRY LAWRENCE GORGAS III

confirms the right to use the waters of FALL CREEK, tributary to PANTHER CREEK for DOMESTIC USE FOR ONE FAMILY, INCLUDING IRRIGATION OF NOT TO EXCEED 1.0 ACRE LAWN AND GARDEN, AND INCLUDING MAINTENANCE OF A 2.84 ACRE-FEET RESERVOIR.

This right was perfected under Permit 11792. The date of priority is JULY 26, 1935. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

3 S	5 W	WM	29	NE NE	589.3 FEET SOUTH & 1125.6 FEET WEST FROM NE CORNER, SECTION 29

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use for domestic use, irrigation, and reservoir maintenance, to which this right is appurtenant, is as follows:

3 S	5 W	WM	21	NW SW	1.0

The use of water for irrigation of a lawn and garden and for maintenance of a reservoir may be made only so long as the water is delivered through the domestic water system and is used in conjunction with the domestic use.


This certificate is issued to confirm a change in USE AND PLACE OF USE approved by an order of the Water Resources Director entered December 5, 1996, at Special Order Volume 50, Page 837, approving Transfer Application 7429, further amended by an order of the Water Resources Director entered May 5, 1998, at Special Order Volume 52, Page 468, and supersedes Certificate 11744, State record of Water Right Certificates.

CONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675 you may either petition for judicial review and may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
