CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGE H. AND HENDRIKA NEARY, TRUSTEES

confirms the right to use the waters of the ROGUE RIVER, a tributary to the PACIFIC OCEAN for IRRIGATION of 92.1 ACRES.

This right was perfected under Permit S-23796. The date of priority is JULY 28, 1955. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.15 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the original point of diversion located in the SWNE of Section 18, Township 36 S, Range 2 W, W.M., described as: 2350 feet South and 1840 feet West from the NE Corner of Section 18.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to correct the conditions described on Certificate 87229. This Certificate supersedes Certificate 87229, and describes the portion of water right Certificate 86997, modified by the provisions of an order of the Water Resources Director entered \_\_\_\_\_, and recorded at Volume \_\_\_\_\_, Page \_\_\_\_\_, reconsidering and approving a change in Point of Diversion Due to Government Action T-11277. Together with Certificate 87230, this certificate supersedes Certificate 86997, State Record of Water Right Certificates.
