confirms the right to use the waters of UNNAMED SPRING A, TRIBUTARY OF CHENEY CREEK, AND UNNAMED SPRING B, TRIBUTARY OF AN UNNAMED NATURAL POND, for DOMESTIC USE FOR ONE FAMILY, INCLUDING THE IRRIGATION OF A NON-COMMERCIAL GARDEN NOT TO EXCEED ONE-HALF ACRE IN AREA FROM SPRING A AND MAINTENANCE OF A NATURAL POND FOR WILDLIFE FROM SPRING B.

This right was perfected under Permit S-50090. The date of priority is APRIL 20, 1987 FOR USE FROM SPRING A AND JUNE 26, 1987 FOR USE FROM SPRING B. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FROM SPRING A FOR DOMESTIC USE AND 0.05 CFS FROM SPRING B FOR MAINTENANCE OF A NATURAL POND FOR WILDLIFE, or its equivalent in case of rotation, measured at the points of diversion.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
